# Welwyn Hatfield Borough Council (WHBC) Local Plan

## **Timetable**

The Council is currently finalising their technical evidence and site assessments.

April – June is scheduled for the drafting of the final version of the Local Plan.

In July–September there will be a final PUBLIC CONSULTATION.

This will be **YOUR** opportunity to comment.

As usual we will provide information and advice to guide you.

The NMDGBS has been busy behind the scenes, working with our planning consultant Jed Griffiths, providing strong evidence to the Council opposing development of the Green Belt.

We are attending all the relevant planning meetings to keep upto-date with the progress of the Local Plan and the ever changing planning policy from central Government.

We are also having detailed discussions with our local Councillors, Council Planning Officers and Grant Shapps MP.

We do intend to hold some public meetings – dates and venues will be advised.

#### Contact your MP

Grant Shapps is currently undertaking a survey of Welham Green residents which will be extended to Brookmans Park and Little Heath in due course. This provides a perfect opportunity to let your MP know the strength of feeling in North Mymms about this housing threat. The existing infrastructure is unable to support the proposed amount of new homes. There will be an increase in the number of cars on the roads, more pressure on oversubscribed local schools and more people waiting in doctors' surgeries not to mention flooding and sewerage concerns. If you value the green fields around our villages, have concerns about the infrastructure, now is your chance. # **Incinerator New Barnfield**

**Success at last**. In July 2015 we finally heard that the Secretary of State had refused the Appeal by Veolia to build a Waste Incinerator, Recycling and Energy Recovery Facility at New Barnfield. The Proposal was originally refused by the Secretary of State in 2014 on Green Belt grounds following the Public Inquiry in 2013 at which we appeared. Veolia have stated that they will not challenge this final Refusal. The NMDGBS were responsible for settling the New Barnfield Action Fund barrister's final costs.

HCC have earmarked the area for waste, employment and/or residential. We are opposing Waste Management on the site as it is within 500 metres of Welham Green residences.

#### **New Chairman**

We were pleased to announce last June that Nigel Matthews OBE was appointed as Chairman of the Society. Nigel is a Brookmans Park resident of long standing and has a wealth of managerial experience.

**New Treasurer** After serving as Treasurer for 5 years, Neil Robinson is standing down.
