

#### **CHAIRMAN'S NOTE**

After a fairly quiet start to 2022, the last few months have been busy.

The Local Plan which had been largely on hold (local councillors sought clarification from central government about the practical impact of various ministerial statements concerning the powers of the planning inspectorate and protection of the Green Belt) suddenly took off in late December as the Council moved to consult on what are called Main Modifications to the original draft plan. These offer some respite for the Green Belt but still accept what we believe is a total target for the Borough which substantially exceeds locally generated "need". We have made this and other points in response to the consultation, now closed, and await, without much optimism, the Inspector's response sometime after the local elections in May.

That said, the mood music has changed. In early December, Michael Gove, Secretary of State for the Department for Levelling Up, Housing and Local Communities issued a letter to members of Parliament setting out his proposals for changes to the rules about local targets and protection of the Green Belt.

"The effect of these changes will be to make absolutely clear that Local Housing Need should always be a starting point - but no more than that - and importantly, that areas will not be expected to meet this need where they are subject to genuine constraints. We will be clear that local planning authorities are not expected to review the Green Belt to deliver housing."

But! As councillors noted in voting last December, these proposals and commitments are not yet in force and may or may not be in place in time to affect the Welwyn Hatfield Local Plan. Please continue to put pressure on our local councillors and MP to oppose development on the Green Belt.

We have also faced a rash of planning applications from developers seeking to anticipate the plan. Last month we joined with CPRE Herts and a newly formed local action Group, Brookmans Park Action Group, to oppose a developer seeking permission to develop land north of Bradmore Way, a site not recommended by the council in the Local Plan. We await the planning inspector's decision.
